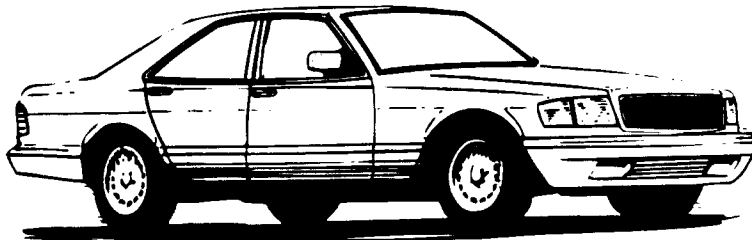
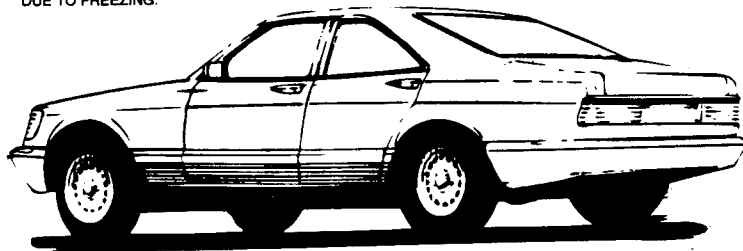

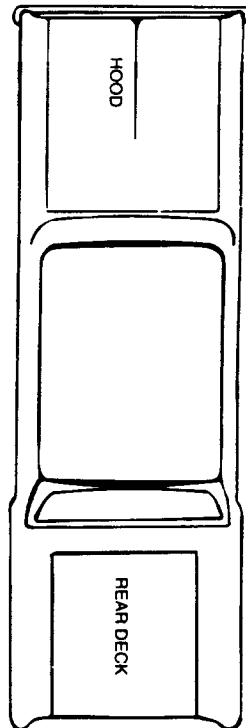

When paint damage occurs and replacement of automobile body parts is not required, the deductible on the face of the certificate or 2.5 percent of the automobile's insured value, whichever is greater, shall apply.
